Vendor Application:

Vendor applications are due by May 31st, but spaces are limited and may fill before the deadline. Apply early to secure your spot!

- 1. Read this information sheet as well as the application.
- 2. Application is neither an offer nor a guarantee of space.
- 3. Please answer all questions completely and legibly. The decision will be based solely on this application.
- 4. The list of products you are requesting to sell/display/promote/give away must be specific. The JCFA reserves the right to select the items a company/organization/person is allowed to sell.
- 5. Fireworks and any hazardous materials are strictly prohibited. Additionally, items that emit loud noises or project objects, which may disturb patrons or fair animals, are not permitted.
- 6. All vendors must show proof of insurance with a minimum liability of \$1,000,000 on Bodily Injury/Property Damage Listing the JCFA as additional insured. Proof of

insurance must be on file in the Fair Office upon completion of the vendor contract.

- 7. All vendors preparing and selling food must have a Health Permit from the Jefferson County Public Health Dept. www.jeffersoncountypublichealth.org
- 8. If a contract is issued, the location of your booth will be determined by JCFA.
- 9. A recent photo of your booth is requested.
- 10. If you are bringing a trailer, a photo is required. Please also provide the total length and any power requirements.

Items to consider before applying

- 1. There are no special discounts for non-profit organizations or services.
- 2. Most spaces include power at no extra cost. Please indicate power requirements.
- 3. Equipment needs are your responsibility and at your expense. JCFA does not provide tables, chairs, electrical cords, adapters, RV adapters, tents, etc.
- 4. **Fair Food vendors:** pay 15% of their gross sales after sales tax or \$300- whichever is greater. A \$300.00 deposit is due with a signed contract to reserve your space.

Fair Non-Food vendors: pay booth fee only no concession fees.

- 5. Booth Space must be staffed: Fair 9:45 am to 8pm Friday & Saturday, Sunday 9:45am -6pm.
- 6. No vehicles are allowed to be driven on the grounds during Fair hours. All deliveries must be made before or after hours.
- 7. If accepted, full booth fee is due with the completed contract.
- 8. Camping is available for a fee on a first come first serve basis.
- 9. We do not grant exclusivity for any products. JCFA reserves the right to limit the number of vendors selling/displaying "like items" in order to provide a wide variety of products and services for the general public. JCFA reserves the right to limit the number of concessionaires offering the same/similar food.
- 10 Except competition animals, trained assistance dogs and police dogs in the performance of duty, no other pets or animals are allowed on the grounds.
- 11. One day spaces may be available on a limited basis attach separate request letter with this application outside spaces only.

Jefferson County Fair: Vendor Application Do <u>not</u> send money with an application. If accepted a contract will be sent to you, which you would sign and return with payment.
